## **Section 51 Manual**

# For InfoStream Technologies cc

## Introduction

This Manual is published in terms of Section 51 of the Promotion of Access to Information Act, 2000 (Act No. 2 of 2000) ("the Act"). The Act gives effect to the provisions of Section 32 of the Constitution, which provides for the right of access to information held by the State and to information held by another person that is required for the exercise and/or protection of any right.

The reference to any information in addition to that specifically required in terms of Section 51 of the Act does not create any right or entitlement (contractual or otherwise) to receive such information, other than in terms of the Act.

## 1. INFOSTREAM TECHNOLOGIES CC OVERVIEW

**InfoStream Technologies cc** provides Internet Services and Access to its customers, in both the corporate and home market. Some of these services include, but are not limited to, access, hosting, security and consulting.

**InfoStream Technologies cc** supports the constitutional right of access to information and we are committed to provide you access to our records in accordance with the provisions of the Act, the confidentiality we owe third parties and the principles of South African law.

The requester must provide sufficient detail on the request form to enable the Information Officer to identify the record and the requester. The requester should also indicate which form of access is required and indicate if he or she wishes to be informed in any other manner and state the necessary particulars to be so informed.

The requester must identify the right that he or she is seeking to exercise or protect and provide an explanation of why the requested record is required for the exercise or protection of that right.

If a request is made on behalf of a person, the requester must then submit proof of the capacity in which the requester is making the request to the satisfaction of the Information Officer of the InfoStream Technologies cc.

The standard form that must be used for the making of requests is available on our website (<a href="http://www.infostream.co.za/paia/FormC.pdf">http://www.infostream.co.za/paia/FormC.pdf</a>). Not using this form could cause your request to be refused (if you do not provide sufficient information or otherwise) or delayed.

## 8.3 Customer records

# 8.5 Other Parties
